This contract is a legal agreement between the Seller and the Purchaser.

Any breach of what it is stipulated in this contract by either the Seller or the Purchaser may lead to legal consequences.

Purchaser agrees to the following:

1: This cat/kitten is sold as a quality breeder cat. It is guaranteed to be free from congenital defects, and genetic diseases for a period of 12 months and we give a guarantee on HCM of 24 months (starting from the moment the cat/kitten leaves the cattery).

1.1: Should the cat/kitten be found to have a congenital defect/ genetic disease or HCM within the 12 months (24 months for HCM) period, the Purchaser must provide the Seller with a certified proof by a licensed veterinarian or cardiologist. The Purchaser must then return the cat/kitten to the Seller, who will replace him/her with a cat/kitten of comparable value and quality when available. The Purchaser will be responsible for shipping fees and/or travel costs on both ways.

1.2: Should the cat/kitten be found to have a congenital defect/ genetic disease or HCM after the 12(24 for HCM) months period, or after that cat/kitten has produced live kittens the Purchaser should notify the Seller who will try to help and advise the Purchaser. The Seller, though, will not be liable for any replacements or refunds.

2: This cat/kitten is guaranteed to be fertile as adult. In the unlikely event that this cat/kitten has not produced viable offspring by the age of 2 years, after being bred to at least 2 or 3 different studs/queens, the Seller agrees to replace the cat/kitten with one of comparable value when available. The Purchaser will be responsible of returning the cat/kitten to the Seller, or altering him/her to be placed in a suitable loving pet home. This must be first discussed between the Seller and the Purchaser. Any shipping fees and/or travel costs on both ways will be covered by the Purchaser.

3: Deposits and Waiting list fees are not refundable, except in the case that the Seller is unable to proceed with the sale.

4: The total cost for the cat/kitten must be paid to the Seller by the Purchaser at latest 1 week before the cat/kitten is ready (unless otherwise agreed).

4.1: If the Purchaser will not comply with what stipulated in point 4, the Seller reserves the rights to keep the deposit and/or waiting list amounts and to re-advertise the cat/kitten.

5: No cash refunds will be given to the Purchaser at any stage, unless his/her veterinarian should find a serious health problem in the cat/kitten, within the period of 72 hours (no contact with other cats). Those 72 hours are calculated from the moment the cat/kitten leaves the Seller's premises.

6: The Purchaser is not allowed to sell or re-home the cat/kitten at any stage of his/her life, without contacting the Seller first.

7: Breeder males are to be used only with the Purchaser's females. Should the Purchaser wish to breed his Stud with an outsider female, that female must be from a registered cattery, and must be free from FIV/FeLV/HCM, congenital defects and genetic diseases. The Purchaser must always contact the Seller first, and receive a written approval. Proofs of negativity to the above mentioned pathologies will be required. The same applies for a breeder female.

8: The Purchaser agrees that all the kittens produced from this cat/kitten will be sold with registration papers, health guarantee to pre-approved homes or registered breeders. Those kittens cannot be sold in litterlots, and cannot be sold to animal laboratories, animal brokers, pet shops or their agents. **Offsprings from this breeding cat can be sold for breeding to any Country EXCEPT SOUTH AFRICA. If this condition is ignored is a R 20000 penalty to be payed to BloupuntBengals.**

9: The Purchaser agrees that this cat/kitten will be exclusively bred with registered pure bred Bengal cats. The cat/kitten cannot be bred with an unregistered cat or a mixed breed cat. If such breeding takes place, the Purchaser's name and personal details will be reported. Furthermore, the cat and kittens will be taken away from the Purchaser.

10: Shall the Purchaser decide not to continue with his/her breeding program, the cat/kitten must be first offered back to the Seller. If the Seller cannot accomodate the cat/kitten, it must be sterilized by the Purchaser. The Purchaser, will then have the option of keeping the cat/kitten as a pet, or finding a suitable home.

10.1: Under no circumstances will the Purchaser sterilize the cat/kitten without first contacting the Seller. The cat/kitten cannot be re-sold for breeding it must be fixed before..If this condition is ignored is a R20000 fine to be paid to BloupuntBengals

11: Under no circumstances may the cat/kitten be leased, given away, sold to pet-shops, animal laboratories or any similar facilities.

12: The Seller has got the right to ask the Purchaser details of his/her house, habits, work, family, presence of other pets, exc... in order to guarantee for the cat/kitten life quality and safety. These details will be kept confidential between the Seller and the Purchaser.

13: The cat/kitten is sold as an indoor breeding cat. It is agreed by the Purchaser that the cat/kitten will not be allowed outside unless with supervision or on a leash.

14: Any health or settling in concerns must be discussed solely with the Purchaser's veterinarian and/or with the Seller. It is not for public discussion.

15: The kitten will be ready to leave the cattery at 12/14 weeks of age. The Seller reserves the right to prolongue this period if the relative kitten is not considered ready to leave the cattery yet.

Health Guarantee:

Our kittens/cats have received their first vaccination at 7/8 weeks of age, and the second one at 12 weeks of age. They have also been dewormed, treated for ticks and fleas and checked twice by our veterinarian.

The next vaccination booster shall be given by the Purchaser at the time indicated on the Vaccination Record book.

The kitten/cat is guaranteed to be in good health when leaving our cattery, and to be free from FIV and FeLV. The kitten/cat is also guaranteed to be negative to genetic diseases such as PRA, PK def and HCM, as all of our Studs and Queens parentage have been tested (PRA, PK def) and yearly tested (HCM).

The good health guarantee is valid for 72 hours after leaving the cattery (see also point 5 in the previous page), providing that the cat/kitten has not being in contact with other cats. The validity is reliant on the cat/kitten being checked by a veterinarian in those 72 hours, and that veterinarian agreeing that the cat/kitten is not in good health.

All the veterinary bills and care are the sole responsibility of the Purchaser, once the good health guarantee has expired.

Should the kitten/cat die due to a congenital defect (which may be not visible during the early stages) within the first 12 months, the Seller will replace the kitten/cat with another one of comparable quality and value when available. No additional costs will be charged to the Purchaser.

A Post Mortem certificate is required to verify the cause of death.

Undesirable Behaviour Issues (spraying, inappropriate urination, scratching of furniture, exc) developing once the cat/kitten has been turned over to the Purchaser, as well as health conditions such as colds, skin rashes, virus and bacterial infections are not considered conditions for return or refund. The Seller is available to assist the Purchaser for any behavioural issues.

Each kitten/cat will differ in the time needed to bond with his/her new family. Please give the kitten ample time to adjust.

Purchaser agrees to provide his/her Bengal with lots of love and a good quality life.
